MEMBERSHIP:

We have two sign up options for you to choose from:

1) ONE TIME BID of \$100.00 which will give you a bid of upto one purchase (Membership fees are nonrefundable).Also we require a payment of minimum \$150 or 10% of your max bid as a security deposit which is refundable made in order for us to bid on the purchase. (Buy It Now items require a minimum \$400 security deposit) We will have to bid on the purchase for you.

2) ANNUAL MEMBERSHIP of \$200.00 which will give you unlimited bids for a year (Membership fees are nonrefundable). Also we require a payment of minimum \$150 or 10% of your max bid as a security deposit which is refundable made in order for us to bid on the purchase. We will have to bid on the purchase for you. A minimum of \$150 security deposit is required to keep the account active.

ADDITIONAL FEES AND PENALTIES:

- **Payment:** You are required to make the full invoice payment to All Team Auto which also includes IAAI fees. If you pay the auction directly without All Team Auto's written approval, you will be entitled to \$150 fine payable to All Team Auto for violation of terms and can also risk in termination of their account with no refund of the membership fees and/or security deposit.
- **Vehicle Inspection:** Any clear title vehicle purchased with 75,000 or more miles will be required for a \$200 engine and drive inspection before the vehicle leave the auction facility. The customer will receive a copy of the inspection. This fee will be added to the invoice when the payment is due.
- All Team Auto will add an additional \$100 to your Transaction Fee for any specialty item (* sign represents it as a specialty item)
- **Late Fees:** All Team Auto & IAAI will also charge a late payment fee if vehicle is not paid by DUE DATE.
- **Relist Fee:** If you fail to pay for a vehicle you will be required to pay a minimum \$1500.00 or 20% of the winning bid amount (whichever is greater) for payment default.
- **Storage:** All Team Auto will allow only four days of past due storage on a vehicle, after which the vehicle will be resold through the auction. Customer will be responsible for all fees to IAAI and All Team Auto. Please note IAAI will charge **\$40 per day** for storage past the grace period for pickup. All Team Auto & IAAI are not responsible for any losses on said vehicle. All Team Auto & IAAI will also charge storage fees if vehicle is not picked up by the PICKUP DATE.
- Some titles will be subject to an additional fee of \$200.

TRANSPORTATION:

- The customer is responsible for the transportation of the purchased vehicle. All Team Auto will be able to assist with the transportation by putting the vehicle on the dispatch board. A deposit will be required for this. However All Team Auto will not be responsible for the transportation, the customer is still responsible for the pick up of their vehicle.

DOCUMENTATION:

- The titles will be mailed to All Team Auto from IAAI directly once the vehicle has been picked up. IAAI has up to 30 days to mail it out to us from the date of the pickup. Please notify anyone who is picking up the vehicle for you not to take the title with them. If the driver is handed the title from the auction, you are responsible for mailing out to us so we can do the necessary documentation.
- Once we receive the title from IAAI we will email you requesting for a drivers license for documents and title to be typed under.
- You will have upto 7 days from the date the documents are emailed to you to have them signed back and email to us or else the security deposit will be forfeited and we will not be responsible for the title. The documents will be emailed to you to the email on file.
- You are required to email the mailing address along with the signed documents. We will mail the original documents to the address on the drivers license if no mailing address has been given in the email.
- You will have upto 14 days from the date the documents were mailed out to you to have the purchase registered in your homestate except for export only purchases. We will not be liable after 14 days for any issue regarding your purchase. We will not be able to do any alterations or changes after the 14 days.

- Security deposit will be refunded in full at the completion of the transaction which is when you receive all the original documents on hand. The refund is processed only when you request for a refund via email to us.

IMPORTANT INFORMATION:

- All Team Auto is subject to use a third party on purchases for salvage and scrap title vehicles.
- You will be sent an invoice via email for the final amount due after we receive it from IAAI during normal business hours. The payment is due within 24 hours from the time the email was sent and it will also be mentioned in the invoice. You will be responsible for any late fees from both IAAI and All Team Auto if the payment is not visible in our account within 24 hours.
- All Team Auto is not liable for any damages, fees or fines for any vehicle incurred after the payment has been received from the customer. Customers are responsible from there onwards. Customers are required to wait for the title before using any vehicle. All Team Auto will not be held liable for any vehicle being impounded or be of help with it.
- You will be able to buy only one vehicle at a time. When the first purchase has been paid for and the amount is visible in our account, you can bid on another vehicle depending on the type of membership you have.
- All Team Auto reserves all rights to deactivate and terminate any account due to a term violation with no refund of the membership fees and/or security deposit.
- As a member of All Team Auto you are required to periodically check our website for updated terms and conditions and we will not be held responsible if you did not check the terms and conditions and there was a possible update to it.
